
#### 5.11.23 Minutes



- d) Sports Club and Roe Green Nothing to report on the play equipment. The Cricket Club will be continuing. 7 years since Sandon have had a football club. The cricket square is being used by The Hertfordshire Veterans Association. Is there a way of being more inclusive and encouraging all ages and genders?
- e) Village Hall fire assessment report and some actions have been addressed. Looking at redecorating the back storeroom. To be spent from the budget.

  Discussed a Christmas tree. Too late for 2023 addressed in budget for December 2024
- f) School open day 2 weeks ago, 9 people attended. A wonderful remembrance service. It is a real asset and is being turned around by the head teacher. They will be holding a Nativity Play
- g) Sandon Saddlery Clir I Dell reported: closed 9 years in January, the house attached is listed and has not been used for over 60 years. There have been many ideas.
  There has been 1 planning application in the past 4 years. Clir I Dell believes there is a possibility of approaching NHDC to compulsory purchase the property. Advised by DClir S Jarvis that Listing Buildings are by English Heritage not council. Clir I Dell to investigate further and report to Parish Council
